

COOKIE POLICY

Our Website <https://www.etos.net.pl/pl> and all the web pages accessible within it use Cookies. In view of the above, we would like to inform you as follows:

1. Definitions

Whenever the 'Cookie Policy' refers to:

- 1) **Cookie Policy** - it shall mean this 'Cookie Policy';
- 2) **ETOS Czesław Szymendera Sp. z o.o.** – it shall mean ETOS Czesław Szymendera Sp. z o.o. with its registered office in Golina, 63-200 Jarocin, Golina, ul. Jarocińska 42, entered in the Register of Entrepreneurs of the National Court Register kept by the District Court Poznań-Nowe Miasto and Wilda in Poznań, 9th Commercial Division of the National Court Register, under KRS number 0001022734, with share capital of PLN 500,000.00, NIP [Tax ID No.] 6172225952, REGON [National Business Reg. No.] 524910601;
- 3) **Website** - it shall mean a set of logically arranged web pages interconnected by navigation and links (homepage and subpages) containing a gallery of photos, videos, audio recordings and documents, made available on the Internet from the single domain address of **ETOS Czesław Szymendera Sp. z o.o.** [etos.net.pl](https://www.etos.net.pl) by means of the web service;
- 4) **web page** - it shall mean any web page (homepage and subpages) accessible within the Website, e.g. <https://www.etos.net.pl/pl/o-firmie/>, <https://www.etos.net.pl/pl/zywienie-zwierzat/> <https://www.etos.net.pl/pl/laboratorium/>;
- 5) **User/you** - it shall mean any natural person visiting the Website;
- 6) **device** - it shall mean a computer or other mobile device which is used by the User while visiting the Website.
- 7) **GDPR** - it shall mean Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR);
- 8) **Privacy Policy** - it shall mean the 'Website Privacy Policy' placed on the Website and informing about the rules of processing personal data of Users using the Website by ETOS Czesław Szymendera Sp. z o.o.

2. Purpose of the Cookie Policy

The purpose of the Cookie Policy is to inform the User using the Website about:

- 1) what Cookies are;
- 2) categories of Cookies used by the Website;
- 3) purposes for which Cookies are used by ETOS Czesław Szymendera Sp. z o.o.;
- 4) Cookie retention period;
- 5) how the User can manage Cookies, i.e. the possibility of defining by the User the conditions for storing or accessing this information by means of settings of the software installed in the device used by the User or the configuration of the service, i.e. the functions offered by the Website.



3. What Are Cookies and Other Similar Technologies?

Cookies are text files (small pieces of data).

Cookies come from ETOS Czesław Szymendera Sp. z o.o., which places and uses them as the Website owner. When you visit the Website, Cookies are sent by the server to your web browser, which saves them on the hard drive of the device you are using.

Depending on the type of Cookies used, they may be deleted when the browser is closed (session Cookies) or, despite leaving the Website, stored in your web browser (persistent Cookies).

If persistent Cookies are used, during your next visit to the Website your browser will return to the server of ETOS Czesław Szymendera Sp. z o.o. the Cookies stored by it in order to re-identify you, i.e. to remind you of the Cookie options selected by you during your previous visit or to inform you about your previous activities.

Cookies allow to identify your device in order to correctly display and use the Website.

Cookies may contain information regarding their origin (domain name of the Website / web page) and lifespan.

Cookies have no adverse effect on the functioning of the device you use. Their use does not result in any changes to the configuration of the device or to the software installed on the device.

The Cookies used by ETOS Czesław Szymendera Sp. z o.o. are not used to collect information about any specific, identifiable person.

4. What Categories of Cookies are Used by the Website and for What Purposes?

The Website uses the following types and categories of Cookies, distinguished according to the purpose of their use:

Type	Categories	General Purpose	Lawful Basis for Processing
Essential Cookies	Technical	These Cookies are installed to provide you with access to the Website and its basic functions. Without the essential Cookies, it would not be possible to display the information (message) on how you can manage the Cookies, and it would not be possible for you to use the Website correctly.	Legitimate interest of ETOS Czesław Szymendera Sp. z o.o., which means that their use by ETOS Czesław Szymendera Sp. z o.o. does not require your consent.



5. How Long Are Cookies Retained?

The Website uses session and persistent Cookies. The table below provides general information on the retention period for each type of Cookie.

Type	Description
Session Cookies	'Session' Cookies are temporary, stored on your device until you leave the Website or switch off your web browser . They help analyse web traffic, identify and resolve technical problems and make it easier to navigate the Website.
Persistent Cookies	'Persistent' Cookies are retained for the period of time specified in their parameters or until they are deleted by you from your web browser . They help to remember your settings and preferences in order to make your next visit to the Website more convenient or provide you with tailored content.

6. What Should You Know about the Cookies Used by this Website?

Details of the Cookies used by the Website are set out in the table below:

7. How Can You Change Cookie Settings?

- 1) You can change your Cookie settings at any time in your web browser. To do so, follow the instructions for enabling/disabling Cookies in your web browser. Information on browser settings is available in the menus of the individual browsers or on their providers' websites. You should always bear in mind that web browser software usually enables Cookies by default on the device you use.
- 2) You can change the Cookie settings in your web browser for example by:
 - a) disabling them completely;
 - b) disabling them on a particular site, e.g. the Website;
 - c) disabling certain types of Cookies;
 - d) deleting them from your device.

You may also set the mode of being informed that the Website/web page wishes to save a Cookie in your browser prior to such saving, in order to take the appropriate action.
- 3) While performing the actions referred to in items 1 and 2, please bear in mind that changes in the Cookie preferences in your browser may make the use of the Website/web page



difficult or impossible. This is so because some Cookies are necessary for the proper functioning of the Website or make the use of the Website more convenient.

8. **Can the Cookie Policy Be Amended?**

- 1) ETOS Czesław Szymendera Sp. z o.o. reserves the right to make amendments to the Cookie Policy when it needs to be updated due to changes made to the Website or when required by law.
- 2) The current version of the Cookie Policy was adopted and is effective as of 08 July 2024.
